## MANUFACTURER'S 10 YEARS LIMITED WARRANTY

### Definition

Under the terms stated below, **Stabilit Europa, s.l.u.** (hereinafter "The Manufacturer") warrants for a period of 10 years from the date of invoice, that the opaque sheets of glass fibre reinforced polyester with two gelcoat layers (top-bottom), manufactured and sold under the name of **Opalit®** (hereinafter "The Product") and distributed by our authorized dealer **WILKES GmbH** under the name of **Duraclad**, will keep the below listed mechanical and physical properties, for a minimum thickness of 1.7 mm.

### Scope of Warranty

- Light transmission of a maximum of 2% determined by test according to standard UNE-EN 1013-1;
- Mechanical stability during the whole period of warranty.
- No fibreglass delamination.
- Breakage: the Product shall not break due to loss of impact strength as a direct and exclusive result of weathering and/or, shall not break as a direct and exclusive result of the impact of hail, measuring up to 25 mm (1") diameter, attaining a velocity of up to 20 m/s. Excessive loss of impact strength will be determined by test according to ISO 6603/1-1985, to be applied on a sample of the broken sheet. This warranty applies only if the sample will be brittle broken in this test into separate pieces.

### Claims and Notifications

Any claim against a fault in the Product must be made in writing. The Manufacturer will not accept any claim that is not accompanied by the original invoice issued on purchasing the Product. The Manufacturer reserves the right to inspect those Products that are subject to a claim in order to submit them to as many tests as it deems necessary or suitable for corroborating the fault. The claimant must allow the staff of the Manufacturer to inspect any or all of the sheets involved and the installation site itself while the sheets are still in their original position and have not been removed/moved/alterd in any way and/or return the sheets to the Manufacturer for testing.

This warranty shall be valid only if the product is handled, stored, cleaned, installed and maintained in accordance with Manufacturer's written instructions.

### Compensation

This warranty is limited to the replacement of the damaged sheets. The new sheets will be delivered by the Manufacturer free of any charge. The Manufacturer's liability does not include any costs of removal and installation of sheets.

### Jurisdiction

This limited warranty shall be governed by and shall be construed according to the laws of Spain. The court in Barcelona shall have the exclusive jurisdiction.

THIS LIMITED WARRANTY SHALL BE THE MANUFACTURERS SOLE WARRANTY TO THE PRODUCT. ANY OTHER CLAIMS FOR DAMAGE OR LOSS EITHER DIRECT, INDIRECT OR CONSEQUENTIAL, WHATEVER THE CAUSE THEREOF, ARE EXPRESSLY EXCLUDED FROM THIS WARRANTY. THIS WARRANTY IS IN LIEU OF ALL OTHERS WARRANTIES, WRITTEN OR ORAL, STATUTORY, EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS OF A PARTICULAR PURPOSE.
